

COMOX VALLEY SKI AND STAY CONTEST

THE **COMOX VALLEY SKI AND STAY CONTEST** (THE "CONTEST") IS INTENDED TO BE CONDUCTED IN CANADA ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THE PROVINCE OF BRITISH COLUMBIA OR OLDER. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

1. ELIGIBILITY. To be eligible for this Contest, an individual must:

- (a) be a legal resident of the "Lower Mainland" area of the province of British Columbia;
- (b) be of the age of majority in his/her province or territory of residence or older at the time of entry.

Employees of **Canwest Television Limited Partnership and Comox Valley Economic Development Society, Mount Washington Alpine Resort, British Columbia Ferry Services Inc., Old House Hotel & Spa, Crown Isle Resort & Golf Community, Kingfisher Oceanside Resort & Spa, Comox Valley Holiday Inn Express & Suites and Travelodge Courtenay** (collectively, the "Sponsors"), their respective affiliates, subsidiaries, related companies, advertising and promotional agencies, and the household members of any of the above, are not eligible to participate in the Contest.

The Sponsors shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to the Sponsors for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant should such an entrant at any stage supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

2. CONTEST PERIOD. The Contest begins at **10:00 a.m.** Pacific Standard Time ("PST") on **Saturday, October 24, 2009** and ends at **11:59 p.m.** PST on **Thursday, December 10, 2009** (the "Contest Period") after which time the Contest will be closed and no further entries shall be accepted.

3. HOW TO ENTER.

- (a) There is no purchase necessary to enter the Contest. Enter using any of the methods of entry outlined below. No entries will be accepted by any other means.
 - (i) To enter by mail, clearly print your name, complete mailing address, daytime telephone number and age at time of entry on a plain piece of paper and submit it to the attention of **Comox Valley Ski and Stay Contest** c/o Comox Valley Economic Development at 102 – 2435 Mansfield Drive, Courtenay, B.C., V9N 2M2.
 - (ii) To enter online, complete and submit the entry form located at **www.discovercomoxvalley.com** (the "Contest Website").
- (b) Limit of one (1) entry per person. In the case of multiple entries, only the first eligible

entry will be considered.

- (c) All entries, become the sole property of the Sponsors and none will be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. No communication or correspondence will be exchanged with entrants except with those selected for a Weekly Prize or Grand Prize.
- (d) Entries submitted by mail must be received by the Sponsors no later than the end of the Contest Period, and must be in a separate outer envelope bearing sufficient postage.

- (a) **Grand Prize.** There is one (1) grand prize available to be won by the **Grand Prize** winner ("**Grand Prize Winner**") consisting of:
 - (i) two (2) 2009/2010 Winter Gold Level Seasons Passes at Mount Washington Alpine Resort;
 - (ii) five (5) passage for two (2) including vehicle aboard B.C. Ferries Mainland to Vancouver Island route during the 2009/2010 winter season;
 - (iii) two (2) night accommodation at each of the following; Old House Hotel & Spa, Crown Isle Resort & Golf Community, Kingfisher Oceanside Resort & Spa, Holiday Inn Express & Suites, Travelodge Courtenay;
 - (iv) two (2) one hour massages at the Old House Hotel & Spa;
 - (v) seventy five (CDN \$75.00) resort card valid at the Crown Isle Resort & Golf Community;
- (b) Grand Prize has an approximate value of fifty-two hundred and sixty-three dollars (CDN \$5263.00).
- (c) Winner is not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.
- (d) **Secondary Prizes.** There are four (4) secondary prizes ("**Secondary Prizes**") available to be won by the Secondary Prize Winner and the details of each prize package will be announced on-air in the Saturday & Sunday Morning News on Global BC on Oct 31,

November 1, 7, 8,14, 15,21 and 22, 2009 .

- (e) Each Secondary Prize has an approximate value of five hundred dollars (CDN \$500.00).
- (f) Winner and his/her Guest must be available to participate in the prize package from December 11, 2009 through to the end of ski season at Mount Washington Resort in 2010. Blackout dates may apply. Should Winner be unable to participate on the dates and times designated by the Sponsors, the Prize will be forfeited and awarded to an alternate winner. Winner will be responsible for transportation to and from the resorts, taxes, gratuities, telephone calls, in-room charges and any other expense not explicitly included in the Prize.
- (g) Guests must comply with the Contest Rules and sign and return the Release (described below).
- (h) Prizes must be accepted as awarded and cannot be transferred, assigned, substituted or redeemed for cash, except at the sole discretion of the Sponsors. Any unused portion of a Prize will be forfeited and have no cash value. The Sponsors reserve the right, in its and their sole discretion, to substitute a prize of equal or greater value if a Prize (or any portion thereof) cannot be awarded for any reason.

5. WINNER SELECTION.

One (1) Winner shall be selected as follows:

- (a) On or about **Friday, December 11, 2009** in Courtenay, British Columbia, one (1) entrant will be selected by a random draw from all eligible entries received during the Contest Period. Each entrant shall be eligible to win only one (1) Prize. The odds of being selected as a potential winner are dependent upon the number of eligible entries received by the Sponsors. Before being declared a Winner, the selected entrant shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail, to comply with the Contest Rules and sign and return the Release (described below).

Four (4) Secondary Winners shall be selected as follows:

WINNERS ON THE TUESDAY FOLLOWING SELECTION AND MUST RESPOND WITHIN TWO (2) BUSINESS DAYS OF NOTIFICATION. Upon notification, the selected entrant must respond by telephone to the contact number provided in the notification, and the selected entrant's response must be received by the Sponsors within two (2) business days of such notification. If the selected entrant does not respond in accordance with the Contest Rules, he/she will be disqualified and will not receive a Prize and another entrant may be selected in the Sponsors' sole discretion until such time as an entrant satisfies the terms set out herein. The Sponsors are not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the Sponsors to receive a selected entrant's response.

- (d) If, as a result of an error relating to the entry process, drawing or any other aspect of the Contest, there are more selected entrants than contemplated in these Contest Rules, there will be a random draw amongst all eligible Prize claimants after the Contest's closing date to award the correct number of Prizes.

The Sponsors are not responsible for any problems, failures or technical malfunction of any telephone network or lines, computer online systems, servers, providers, computer equipment, software, e-mail, players, or browsers, on account of technical problems or traffic congestion on the Internet, at any website, or on account of any combination of the foregoing or otherwise. The Sponsors are not responsible for any injury or damage to entrant or to any computer related to or resulting from participating or downloading materials in this Contest. Entrant assumes liability for injuries caused or claimed to be caused by participating in the Contest, or by the acceptance, possession, use of, or failure to receive any Prize.
