

THE ESCAPE TO COMOX VALLEY CONTEST

THE **ESCAPE TO COMOX VALLEY CONTEST** (THE "CONTEST") IS INTENDED TO BE CONDUCTED IN CANADA ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THE PROVINCE OF BRITISH COLUMBIA OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

1. **ELIGIBILITY.** To be eligible for this Contest, an individual must:
 - a. be a legal resident of the province of British Columbia;
 - b. be of the age of majority in his/her province or territory of residence or older at the time of entry.

Employees of Canwest Media Inc. and Comox Valley Economic Development Society (collectively, the "Sponsors"), their respective affiliates, subsidiaries, related companies, advertising and promotional agencies, and the household members of any of the above, are not eligible to participate in the Contest.

The Sponsors shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to the Sponsors for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. 2. **CONTEST PERIOD.** The Contest begins at 5:30 a.m. Pacific Standard Time ("PST") on June 4, 2008 and ends at 11:59 p.m. PST on Sunday, July 6, 2008 (the "Contest Period") after which time the Contest will be closed and no further entries shall be accepted.
3. **HOW TO ENTER.**
 - a. There is no purchase necessary to enter the Contest. Enter using any of the methods of entry outlined below. No entries will be accepted by any other means.
 - i. To enter by mail, clearly print your name, complete mailing address, daytime telephone number, answer to skill testing question and age at

time of entry on a plain piece of paper and submit it to the attention of The Escape to Comox Valley Contest c/o Comox Valley Economic Development at 102-2435 Mansfield Drive, Courtenay, B.C., V9N 2M2.

- ii. To enter online, complete and submit the entry form located at www.discovercomoxvalley.com (the “**Contest Website**”).
- b. Limit of one (1) entry per person. In the case of multiple entries, only the first eligible entry will be considered.
 - c. All entries become the sole property of the Sponsors and none will be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. No communication or correspondence will be exchanged with entrants except with those selected for a Grand Prize.
 - d. Entries submitted by mail must be received by the Sponsors no later than the end of the Contest Period, and must be in a separate outer envelope bearing sufficient postage.
 - e. Entries received online shall be deemed to be submitted by the authorized account holder of the e-mail address associated with the entry. iii. **Mount Washington Alpine Resort Summer Escape**

Return airfare for two (2) with West Coast Air, two (2) nights accommodation in a one (1) bedroom condominium, Alpine Action Pack of tickets for two (2) to include the Mile High Chairlift, Bungee Trampoline, and (compact) car rental with National Car Rental. Grand Prize has an approximate value of nine hundred and fifty dollars (CDN \$950.00). Gift Certificates expire on September 18, 2008 and prize package is subject to availability and has no cash value. Prize is non-transferable, must be accepted as awarded. Prize is valid from June 19-September 18, 2008 only. West Coast Air is subject to availability and flight schedule. Winners are responsible for all taxes, fees, coverages and fuel associated with car rental. Blackout dates for car rental as follows: Oct 8-12, Nov 5-10, Dec 15/08 - Jan 4/09. Car rental expires Feb 10/09.

iv. **Old House Village Suites and Hotel**

Return airfare for two (2) with West Coast Air, two (2) nights Accommodations at the Old House Village Suites and Hotel in a one (1) bedroom suite, one (1) fifty dollar (CDN \$50.00) dining certificate at Tomato Tomāto Tomato, and (compact) car rental with National Car Rental. Grand Prize has an approximate value of twelve hundred dollars (CDN \$1200.00). Gift Certificate is subject to availability and valid from September 2, 2008-December 20, 2008. West Coast Air is subject to availability and flight schedule. Winners are responsible for all taxes, fees, coverages and fuel

associated with car rental. Blackout dates for car rental as follows: Jul 16 - Aug 23, Oct 8-12, Nov 5-10, Dec 15/08 - Jan 4/09. Car rental expires Feb 10/09.

- b. Winner is not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.

Prizes will be distributed within two (2) business days after Winner has been successfully contacted and notified of his/her Prize and fulfilled the requirements set out herein.

Grand Prize Winner must be available to travel on the dates designated by the sponsor. Should Grand Prize Winners be unable to travel/participate on the dates and times designated by the Sponsors, the Prize will be forfeited and awarded to an alternate winner. Grand Prize Winner will be responsible for transportation to and from originating airport, travel and medical insurance, travel documentation, airport improvement fees, taxes, gratuities, telephone calls, in-room charges and any other expense not explicitly included in the Grand Prize.

- a. On or about Monday, July 7, 2008 in Courtenay, British Columbia, four (4) entrants will be selected by a random draw from all eligible entries received during the Contest Period. Each entrant shall be eligible to win only one (1) Prize. The odds of being selected as a potential winner are dependent upon the number of eligible entries received by the Sponsors. Before being declared a Winner, the selected entrant shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail, to comply with the Contest Rules and sign and return the Release (described below).

- b. THE SELECTED ENTRANT WILL BE NOTIFIED BY TELEPHONE OR E-MAIL NO LATER THAN TUESDAY, JULY 8, 2008 AT 10:00 A.M. AND MUST RESPOND WITHIN TWO (2) BUSINESS DAYS OF NOTIFICATION. Upon notification, the selected entrant must respond by telephone to the contact number provided in the notification, and the selected entrant's response must be received by the Sponsors within two (2) business days of such notification. If the selected entrant does not respond in accordance with the Contest Rules, he/she will be disqualified and will not receive a Prize and another entrant may be selected in the Sponsors' sole discretion until such time as an entrant satisfies the terms set out herein. The Sponsors are not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the Sponsors to receive a selected entrant's response.
- c. If, as a result of an error relating to the entry process, drawing or any other aspect of the Contest, there are more selected entrants than contemplated in these Contest Rules, there will be a random draw amongst all eligible Prize claimants after the Contest's closing date to award the correct number of Prizes.

The Sponsors assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries. The Sponsors are not responsible for any problems, failures or technical malfunction of any telephone network or lines, computer online systems, servers, providers, computer equipment, software, e-mail, players, or browsers, on account of technical problems or traffic congestion on the Internet, at any website, or on account of any combination of the foregoing or otherwise. The Sponsors are not responsible for any injury or damage to entrant or to any computer related to or resulting from participating or downloading materials in this Contest. Entrant assumes liability for injuries caused or claimed to be caused by participating in the Contest, or by the acceptance, possession, use of, or failure to receive any Prize. The Sponsors assume no responsibility or liability in the event that the Contest cannot be conducted as planned for any reason, including those reasons beyond the control of the Sponsors, such as infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or corruption of the administration, security, fairness, integrity or proper conduct of this Contest, the Contest Website, and/or canada.com.
10. **CONDUCT.** By participating in the Contest, each entrant agrees to be bound by the Contest Rules, which will be posted at the Contest Website and made available at Global Television, 7850 Enterprise Street, Burnaby, British Columbia throughout the Contest Period. Entrant further agrees to be bound by the decisions of the Sponsors, which shall be final and binding in all respects. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant found to be: (a) violating the Contest Rules; (b) tampering or attempting to tamper with the entry process or the operation of the Contest the Contest Website, or any canada.com website; (c) violating the terms of service, conditions of use and/or general rules or guidelines of any canada.com property or service; and/or (d) acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person. 13. TERMINATION. Sponsors reserve the right, in their sole discretion, to terminate the Contest, in whole or in part, and/or modify, amend or suspend the Contest, and/or the Contest Rules in any way, at any time, for any reason without prior notice.

14. LAW. These are the official Contest Rules. The Contest is subject to applicable federal, provincial and municipal laws and regulations.
